



PRIVACY POLICY

GEDIPE - ASSOCIATION FOR THE COLLECTIVE MANAGEMENT OF COPYRIGHT AND CINEMATOGRAPHIC AND AUDIOVISUAL PRODUCERS hereby declares and guarantees, for the purposes of Regulation (EU) 2016/679 and other applicable national legislation that it conforms its practice with the provisions of Law 41/2004 on the protection of personal data in the electronic communications sector (which transposes Directive 2009/136/EC of the European Parliament and of the Council of 25 November 2009 amending Directive 2002/22/EC on universal service and users' rights relating to electronic communications networks and services, Directive 2002/58/EC concerning the processing of personal data and the protection of privacy in the electronic communications sector and Regulation (EC) No 2006/2004 on cooperation between national authorities responsible for the enforcement of consumer protection laws.

GEDIPE does not use "cookies" nor does it collect data concerning users who visit this website.

Any personal data that may be provided by any natural person will only be available on GEDIPE servers for a period of time deemed necessary and appropriate for the specific purpose of the processing, after which they will be erased in accordance with the practice of the Portuguese Regulator (CNPD - National Commission Data Protection) whose website is www.cnpd.pt.

GEDIPE is the entity responsible for processing the personal data that may be collected by itself.

The personal data processed by GEDIPE are only and strictly for the management, collection and distribution of amounts due to all right holders, pursuant to section 184 of the CDADC or the dissemination of Copyright and Related Rights and the promotion of its activities with transparency, under the terms and for the purposes of the Law of Collective Management Organisations (Law no. 26/2015 of April 14 in the drafting of Decree-Law no. 100/2017 of August 23).

GEDIPE adopts strict security procedures regarding the storage and disclosure of personal data that it may collect, as well as its protection against accidental damage, loss or destruction. The personal data eventually collected is protected through the use of periodically alterable access encryption and password protection technologies.

All access by duly authorized personnel is registered during the six-month period.



The personal or traffic data that may be obtained by GEDIPE cannot and will not be used for any direct marketing purpose or any commercial purpose, including profiling or any other automated decision making process and are subject to portability on request, in accordance with article 20 of the GDPR. GEDIPE will comply with the above-referenced GRDP and any other applicable legal provisions and will not copy, reproduce, adapt, modify, erase, destroy, diffuse, transmit, divulge or otherwise make available to third parties personal data that may have been entrusted to GEDIPE, without having been expressly authorized, nor the use for any other purposes, for its own benefit or of third parties.

Any personal data collected will be dealt with through the use of technical and organizational measures to ensure that data access entities provide high security guarantees and ensure compliance with applicable privacy and data protection legislation.

By becoming aware of this privacy policy and continuing to consult and navigate this website, the holder of the personal data confirms that it is willing to accept the privacy policy of GEDIPE, as expressed above and modified from time to time, and that it is aware of the rights which it enjoys in relation to its own personal data pursuant to GPDR (EU) 2016/679 of the European Parliament and of the Council of 27/04, Chapter 3, in accordance with and for the purposes set out in particular in Articles 12 To 22, such as, in particular, rights of access, rectification, deletion, restriction of processing, and opposition to data processing, as described below:

- Access: the right of the holders of personal data to access their personal data that have been provided by you, without undue delay or excessive costs;
- Rectification: the right of personal data holders to demand that their data be accurate and up-to-date, and may request rectification from GEDIPE, as described below;
- Forgetfulness: the right of personal data owners to require the removal of their personal data from GEDIPE's records when they cease to be used for the purposes for which they were collected, without prejudice, however, to the retention periods established by law impose themselves;
- Opposition: the right of the the personnel to object, free of charge, to the processing of such personal data for the purposes of direct marketing, automated processing or profiling;




- Data Portability: the right of the holders of personal data to receive the personal data they have provided to GEDIPE, in a structured format, in current use and automatic reading, and transmit that data to another controller;
- Treatment limitation: the right of the owners of personal data to, in certain circumstances, ask GEDIPE to limit the processing of their data, namely: (i) when they contest the accuracy of the personal data, during a period that allows the GEDIPE to verify its accuracy; (ii) if the processing is unlawful and the owners of personal data oppose the erasure of the same personal data, requesting, however, the limitation of its use; or (iii) when GEDIPE no longer requires the personal data of the holders of such personal data for processing purposes, but such data is required by the owners of personal data for the purposes of declaration, exercise or defense of a right in a judicial process.

The holders of personal data may also withdraw their consent at any time, when applicable, by going to the electronic address or address identified above. It should be noted, however, that if there is a legally imposed rule or obligation that overrides these rights, GEDIPE will respond by noting the impossibility of executing the request, stating the respective grounds. The holders of personal data also have the right to submit a complaint to the Portuguese Control Authority, the National Data Protection Commission (www.cnpd.pt), without prejudice to other administrative or judicial proceedings, if they consider that the GEDIPE, or another person or entity that treats their personal data on behalf of GEDIPE, violated some of their rights as holders of the same personal data.

GEDIPE may modify its Privacy Policy at any time. The most up-to-date version will always be available on this website and will govern its use of the information of the personal data holders.
